Agenda Item No. 1:

Consideration of 11 Deferred Cases (as per Annexure-I)

The Committee reviewed 11 cases which had been deferred in the previous meeting held on 16.09.2025 for placing before the next meeting after providing handholding support to the applicants.

It was noted that all these applicants were given sufficient opportunity to complete the requisite documents in accordance with the PMEGP scheme guidelines. However, despite repeated reminders and support, none of the applicants submitted the required documents within the stipulated period.

After due deliberation, the Committee decided to reject all 11 deferred cases for non-compliance with documentation requirements.

Scrutiny of 56 New Cases under the PMEGP Scheme (as per Annexure-II)

The Committee examined a total of 56 new cases, received district-wise, for consideration under the PMEGP Scheme. After detailed scrutiny and deliberation, the Committee approved 05 cases for forwarding to the concerned financing banks and 51 cases for rejection, based on deficiencies observed in documents and eligibility criteria.

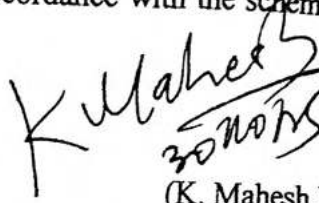
