#### OPENING OF TENDER

In the event of more than one bidder becomes L1, the Competent Authority in DKVIB reserves the right to select one of the L1 bidders based upon various norms like having done Fashion shows, quality of work and experience by having Fashion shows for Export Promotion Council or Central Govt. or State Govt. which are supported by work order etc.

- The Convention Centre, The Ashok, Chanakyapuri, New Delhi, site for the Fashion show and 24 stalls shall be made available for inspection on working days except on Sunday and Public Holidays.
- 3. a) The firm should quote rate and amount in the figures as well as in words. The amount for each item should be worked out and the requisite totals given.
  - b) Special care should be taken to write the rates in figures as well as in words, and the amounts in figures only in such a way that interpolation is not possible. The total amount should be written both in figures and in words. In case of figures, "Rs." should be written before the figures of rupees and "P" after the decimal figures, e.g., Rs. 2.15 P, and in case of words, the word 'Rupees' should precede and the word "Paise" should be written at the end. Unless the rates are in only rupees and followed by the words 'only' it should invariably be up to two decimal places.
