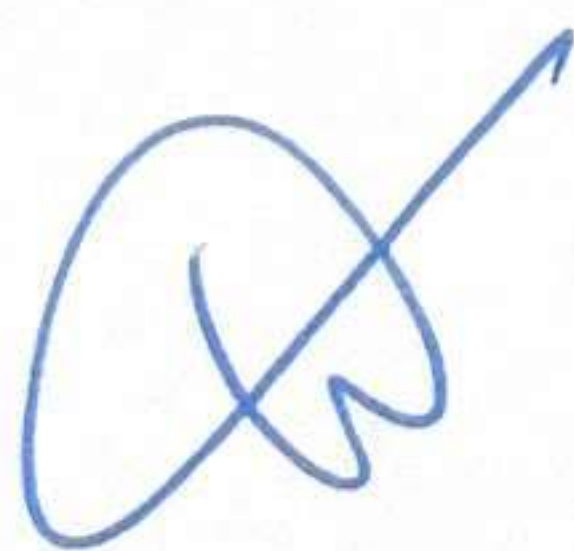
Minutes of the Technical Evaluation Committee Meeting

Subject: Technical Evaluation and award of marks to the Technically Qualified Bidders under engagement of agency for Development of e-Catalogue for Up-skilling and Recognition of Prior Learning (RPL) Training in Tailor Trade (Sewing) under DKKVY. (Tender ID No. 2026_DKVIB_293133_1).

1. e-Tender for engagement of agency for Development of e-Catalogue for Up-skilling and Recognition of Prior Learning (RPL) Training in Tailor Trade (Sewing) under DKKVY was invited in two bid system i.e. Technical and Financial bid. The Technical Evaluation Committee was held on 22.07.2026 in the Conference Hall, Delhi Khadi & Village Industries Board (DKVIB), 5th Floor, Nigam Bhawan, Kashmere Gate, Delhi, under the Chairmanship of the Managing Director, DKVIB, to evaluate and marking of the Power Point Presentations submitted by the 03(Three) technically qualified bidders.

3. The Technical Evaluation Committee met on 22.07.2026 to undertake the Power Point presentation in compliance of RFP. The following three bidders were recommended on the basis of Minutes issued vide No. F3(6)/DKVIB/CT/2026-27/1617-1623 dated 20.07.2026 by the Technical Evaluation Committee for Power Point presentation:
 - 1) NH Consulting Pvt. Ltd
 - 2) Apparel Training & Design Centre
 - 3) Wazir Advisor Pvt. Ltd
4. The Power Point presentations were evaluated on parameters such as implementation methodology, project execution plan, training strategy, organisational capability, technical

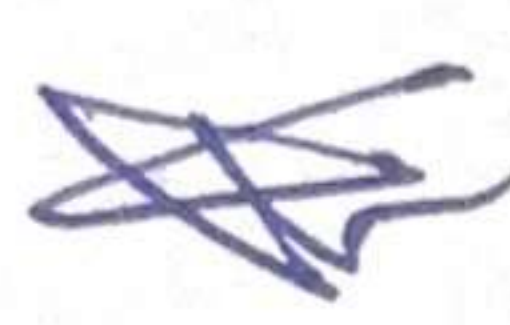
approach, manpower deployment, monitoring mechanism, and overall understanding of the assignment, and marks were awarded jointly by the Committee members and consolidated in accordance with the evaluation methodology stipulated in the RFP. Based on the detailed Technical Evaluation and assessment of the presentations, the Committee declared (1) M/s Apparel Training & Design Centre (ATDC) and (2) M/s Wazir Advisor Pvt. Ltd. as technically qualified bidders and M/s N H Consulting Pvt. Ltd. could not found qualified under the prescribed evaluation criteria, as the agency failed to secure the minimum qualifying marks on a combined basis in the Technical Evaluation and the PowerPoint Presentation.

5. Based on the technical evaluation, the Committee selected the above two bidders and sought approval of the Competent Authority for opening their Financial bids. Accordingly, the Financial bids were opened online on 22.07.2026 at 4:15 PM through the NIC e-Procurement Portal (Tenders Delhi), Government of NCT of Delhi, in the presence of the members of the Technical Evaluation Committee. 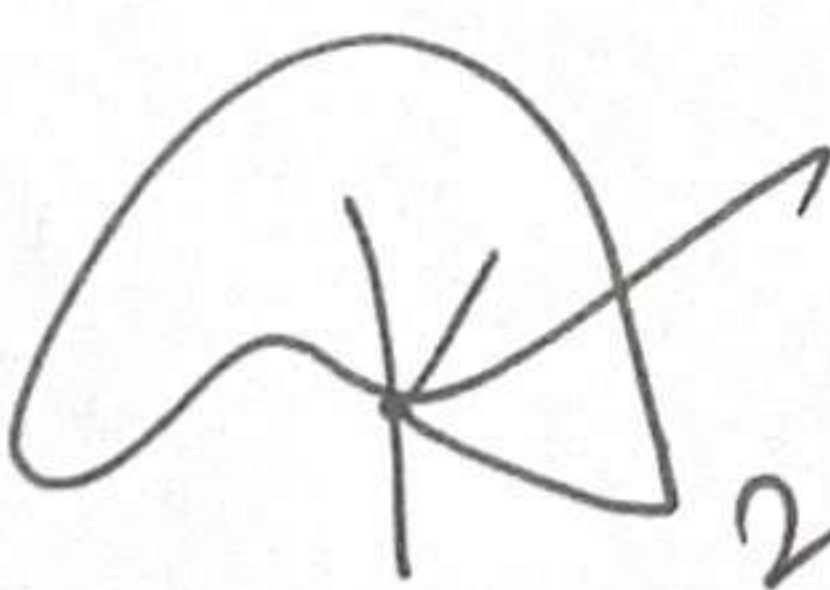

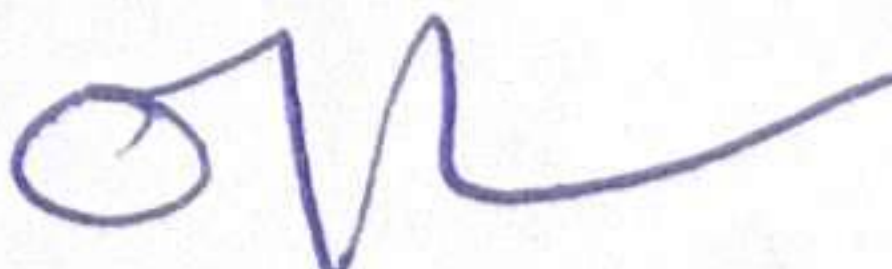

Minutes of the Technical Evaluation Committee Meeting

Subject: Technical Evaluation of Bids received against the Requests for Proposal (RFPs) issued under the Delhi Khadi Kaushal Vikas Yojna (DKKVY) for (i) Empanelment of Implementing Agencies for Up-skilling and Recognition of Prior Learning (RPL), and (ii) Engagement of Agency for Development of e-Catalogue.

1. The Technical Evaluation Committee met on **02.07.2026 at 2:30 PM** in the Conference Hall, Delhi Khadi & Village Industries Board (DKVIB), 5th Floor, Nigam Bhawan, Kashmere Gate, Delhi-110006 Delhi, under the Chairmanship of the Managing Director, DKVIB, to consider and evaluate the Technical Bids received against the following Requests for Proposal (RFPs) issued under the Delhi Khadi Kaushal Vikas Yojna (DKKVY):

- (i) **RFP/Tender ID No. 2026_DKVIB_293135_1 – Empanelment of Implementing Agencies for Up-skilling and Recognition of Prior Learning (RPL) Training under DKKVY.**
- (ii) **RFP / Tender ID No. 2026_DKVIB_293133_1 – Engagement of Agency for Development of e-Catalogue for Up-skilling and Recognition of Prior Learning (RPL) Training in Tailor Trade (Sewing) under DKKVY.**

3. The Committee was apprised that services of the Up-skilling/Recognition of Prior Learning(RPL) was not available on the GeM Portal. Therefore, the process for floating of e-Tender was made through e-Procurement portal under Tenders Delhi, Govt. of NCT of Delhi e-Procurement System <https://govtprocurement.delhi.gov.in/>.

4. The draft RFP documents had earlier been examined by the Local Purchase Committee (LPC) in its meeting held on 05.06.2026. Based on the recommendations of the LPC and with the approval of the Competent Authority, the RFPs were uploaded on the Government of NCT of Delhi e-Procurement Portal and the official website of DKVIB on 11.06.2026 at 10.00AM. Wide publicity was also given through publication of tender notices in Navbharat Times (Hindi) and The Times of India (English).

5. The following 14(Fourteen) bids were received against **Tender ID No.2026_DKVIB_293135_1** – Empanelment of Implementing Agencies for Up-skilling and Recognition of Prior Learning (RPL) Training under DKKVY in the Tenders Delhi, Govt of NCT of Delhi e-Procurement System portal (link is <https://govtprocurement.delhi.gov.in/>).

6. In another **Tender ID No. 2026_DKVIB_293133_1** – Engagement of Agency for Development of e-Catalogue for Up-skilling and Recognition of Prior Learning (RPL) Training in Tailor Trade (Sewing) under DKKVY following 03(Three) bids were received:

- 1) NH Consulting Pvt. Ltd
- 2) Apparel Training & Design Centre
- 3) Wazir Advisor Pvt. Ltd

7. The Committee further noted that a Pre-Bid Meeting with prospective bidders was held on 25.06.2026 at 11:00 AM in the Conference Hall of DKVIB. The Committee observed that the representations received from the prospective bidders included the inclusion of Public Limited Companies as eligible entities and modification of the experience criteria by providing that the bidder should have experience of imparting up to 5,000 skill trainings, as per the cost norms of the Ministry of Skill Development and Entrepreneurship (MSDE), Government of India, calculated as the average during the five consecutive financial years 2021-22, 2022-23, 2023-24, 2024-25 and 2025-26. After due deliberation, the Committee found the proposed modifications to be reasonable and conducive to wider competition. Accordingly, it was decided to incorporate the aforesaid changes in the both RFP documents, and a Corrigendum were issued and uploaded on 29.06.2026 e-Procurement portal i.e. Tenders Delhi, Govt of NCT of Delhi e-Procurement System <https://govtprocurement.delhi.gov.in/> and on DKVIB portal <https://dkvib.delhi.gov.in>.

8. The Committee noted that the last date and time for submission of online bids was 02.07.2026 (Forenoon) and the Technical Bids were opened on the same day at 2:30 PM in accordance with the prescribed procedure. A total of 14 (Fourteen) bids were received for the Up-skilling/RPL tender and 03 (Three) bids were received for the e-Catalogue tender.

9. As ~~per the direction of~~ the Committee detailed scrutiny carried out of total 14 bids received in e-Procurement portal i.e. Tenders Delhi, Govt. of NCT of Delhi e-Procurement System <https://govtprocurement.delhi.gov.in/> against e-Tender ID No. 2026_DKVIB_293135_1 with reference to the eligibility conditions, technical qualification criteria and documents prescribed in the RFP. The comparative statement and scrutiny report placed ~~before~~ the Committee revealed that only 02 (Two) (1. The Apparel Training & Design Centre, 2. Wazir Advisor Pvt. Ltd) bidders fulfilled all mandatory eligibility and technical qualification requirements and were declared technically qualified. The remaining 12 (Twelve) bidders were not technically qualified due to non-fulfilment mandatory conditions prescribed in the terms and conditions of the above said e-Tender document. The comparative statement of all 14 bidders is tabulated at **Annexure-1**.

10. The Committee thereafter examined the Technical Bids received against Tender ID No. 2026_DKVIB_293133_1 relating to engagement of an agency for development of e-Catalogue. After detailed scrutiny of the documents submitted by the bidders, the Committee found that all 03 (Three) (1. NH Consulting Pvt. Ltd, 2. Apparel Training & Design Centre, 3. Wazir Advisor Pvt. Ltd) bidders fulfilled the prescribed eligibility and technical qualification criteria and were accordingly declared Technically qualified. The comparative evaluation statement is placed at **Annexure-2**.

11. The Committee noted that, as provided in the respective RFP documents, only technically qualified bidders are eligible to participate in the subsequent evaluation stage through presentation of their implementation methodology, operational framework and technical approach before the Technical Evaluation Committee.

12. After detailed deliberations, the Committee unanimously resolved as under:

- (i) To approve the Technical Scrutiny Reports and Comparative Statements in respect of both RFPs.
- (ii) To declare 02 (Two) bidders under Tender ID No. 2026_DKVIB_293135_1 as Technically qualified and 12 (Twelve) bidders as Technically not qualified.
- (iii) To declare all 03 (Three) bidders under Tender ID No. 2026_DKVIB_293133_1 as Technically qualified.
- (iv) To invite the technically qualified bidders under both RFPs to make PowerPoint Presentations before the Technical Evaluation Committee, a suitable date and time to be fixed, so that the qualified bidders may be communicated, in accordance with the provisions of the respective RFP documents.
