- The meeting was chaired by the Managing Director, DKVIB, who welcomed all participating candidates and gave an overview of the tender scope and objectives. It was conveyed that the purpose of the pre-bid meeting was to clarify any doubts or concerns of the prospective bidders regarding the tender document and ensure a transparent fair bidding

- 5. It was informed to the candidates that the corrigendum related to the tender has already been uploaded on the website of DKVIB and e-procurement portal of GNCTD on 14.07,2025. The corrigendum was read out during the meeting and explained in detail. It was also informed that tender shall be accepted only through online mode via designated e-procurement portal of GNCTD.
- 6. The query raised by Ms. Zoya of M/s Total Performance that the amount mentioned in tender is Rs. 26.00 lacs is without GST or not. It is clarified that the GST will be paid extra, as applicable, in accordance with the prevailing rules.
- 7. Another query raised by Sh. Vijay Roy of M/s Vroy Creative Agency about the terms and conditions of the payment. It is clarified that as per provision of GFR 172, advance payment up to 30% can be released against submission of a valid Bank Guarantee. The balance payment shall be made within 45 days of submission of the final bill.
- 8. Further, it is also clarified to all that a valid MSME certificate must be uploaded on or before 23.07.2025. The power point presentation (PPT) shall be made by the technically qualified and eligible bidder for finalization of technical bid on 25.07.2025 at 11.00 AM, and financial Bid shall be opened immediately thereafter.
- All queries were resolved to the satisfaction of candidates. The candidates appreciated transparency and clarity. They were once again remind to submit complete documents online only and adhere to deadline of 3.00 p.m. on 23.07.2025.
